- Where the required information cannot be furnished in the space provided, the information must be submitted as a separate memorandum and attached hereto, and clearly indicated and marked as annexures.
- The deed of cession must be accompanied by the original application for registration of deed of mortgage. The deed of cession must be signed by-
  - the transferor if a natural person;
  - the partner duly authorised to execute documents on its behalf, if the transferor is a partnership; or
  - the officer(s) duly authorised to execute documents on its behalf, if the transferor is a company, close corporation, or organisation.
