# SUBMISSION OF INITIAL CABIN CREW SKILLS TESTS REPORTS AFTER WRITING THE SACAA CABIN **CREW EXAM**

## 1. Applicability

The South African Civil Aviation Regulations (SACAR) of 2011 Part 64.02.4.(2) states:

The applicant shall undergo the skills test referred to in sub-regulation (1) within six months of passing the theoretical knowledge examination referred to in regulation 64.02.3 and within the 90 days immediately preceding the date of application.

## 2. Purpose of this General Notice

It has emerged that initial cabin crew candidates undergo practical skills tests prior to successful completion of the South African Civil Aviation Authority (\*SACAA\*) cabin crew examination. This is inconsistent with the provisions of the SACAR referred to above. The standing requirement is for the completion of the cabin crew examination before a skills test is conducted.

Due to the nationwide Covid-19 lockdown that commenced on 27 March 2020, there are a number of initial cabin crew applicants that have not yet written the SACAA exam successfully, who have however conducted a skills test before lockdown and have exceeded the 90 day requirement for submission of an application of a cabin crew member license.

This General Notice serves to address the identified non-compliance and provide a dispensation for affected initial cabin crew applicants.

#### 3. General condition

The SACAA has approved the following process for pending and future applications for initial cabin crew membership license:

- All skills tests conducted during February 2020 will be valid until 31 August 2020 provided that a SACAA cabin crew exam is written and passed by 31 August 2020. A refresher course, as detailed in CAR 121.03.9, shall also be given to the candidates before they write the SACAA exam.
- All skills tests conducted during March 2020 will be valid until 30 September 2020 provided that a SACAA cabin crew exam is written and passed by 30 September 2020. A refresher course, as detailed in CAR 121.03.9, shall also be given to the candidates before they write the SACAA exam.

- Any skills tests conducted until 31 August 2020 will still be accepted by the licensing officers even if it was conducted before the SACAA exam.
- As from 1 September 2020 all candidates and ATO's shall comply with the regulation as stated above. All skills test shall only be conducted <u>after</u> the SACAA exam has been passed.
- The examination center will, with immediate effect, no longer require skills tests when an examination booking is made for a candidate or when they arrive for the exam. The skills test will be required as part of the application for a cabin crew member license.

#### 4. Decision by the Director of Civil Aviation

The SACAA reserves the right to amend the decisions contained in this notice should circumstances dictate the necessity thereof. Please note: If there are any regulatory changes this Notice will be subject for review.
