SCHEDULE**CONVENTION ON THE INTERNATIONAL RECOGNITION OF RIGHTS IN
AIRCRAFT ACT, 1993 (ACT No. 59 OF 1993)****FIFTH AMENDMENT OF THE MORTGAGING OF AIRCRAFT REGULATIONS,
2024****GENERAL EXPLANATORY NOTE:**

Interpretation

1. In this Schedule "the Regulations" means the Mortgaging of Aircraft Regulations, 1997, published by Government Notice No. R. 1739 dated 24 December 1997, as amended.

Amendment of Regulation 8 of the Regulations

2. Regulation 8 of the Regulations is hereby amended by the substitution for Regulation 8 of the following Regulation:

"8. Fees

The following fees shall be payable when application is made for:

(a) The recording of a mortgage in the register of aircraft mortgages	[1840.00] <u>2255.00</u>
(b) A notification of the discharge of a mortgage	[1840.00] <u>2255.00</u>
(c) A transfer of mortgages by deed of cession	[1840.00] <u>2255.00</u>
(d) A declaration of transmission of rights in a mortgage	[1840.00] <u>2255.00</u>
(e) A certificate of mortgage	[1370.00] <u>1680.00</u>
[(f) Access to the register of aircraft mortgages	230.00
(g) The furnishing of a copy from the register of aircraft mortgages	1.60]

***Note:** The process and fees for obtaining access to the register of aircraft mortgages and copies thereof is stipulated in the SACAA Access to Information Manual obtainable under the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000) ("PAIA") and privacy tab on the South African Civil Aviation website."*

Short title and Commencement

3. This amendment is called the Fifth Amendment of the Mortgaging of Aircraft Regulations, 2024 and shall come into operation 30 days after the date of publication in the Government Gazette.

Wysiging van regulasie 8 van die regulasies

2. Regulasie 8 van die Regulasies word hiermee gewysig deur die vervanging van Regulasie 8 met die volgende Regulasie:

"8. Gelde

(a) Die optekening van 'n verband in die register van lugvaartuigverbande	[1 840.00] <u>2 255.00</u>
(b) 'n Kennisgewing van die aflossing van 'n verband	[1 840.00] <u>2 255.00</u>
(c) 'n Oordrag van verbande deur sessie-akte	[1 840.00] <u>2 255.00</u>
(d) 'n Verklaring van oorgang van regte by 'n verband	[1 840.00] <u>2 255.00</u>
(e) 'n Verbandsertifikaat	[1 370.00] <u>1 680.00</u>
[(f)Toegang tot die register van lugvaartuigverbande	230.00
(g) Die verskaffing van 'n afskrif die register van lugvaartuigverbande	1.60]

Nota: Die proses en gelde vir die verkryging van toegang tot die register van lugvaartuigverbande en afskrifte daarvan word bepaal in die SABLO se Toegang tot Inligting Handleiding wat beskikbaar is onder die Wet op Bevordering van Toegang tot Inligting, 2000 (Wet No. 2 van 2000) ("WBTI") en die privaatheid-oortjie op die Suid-Afrikaanse Burgerlugvaart se webtuiste."
