(ACT NO.41 OF 1998)****NOTICE OF AN AMENDMENT OF A DETERMINATION MADE BY THE SOUTH AFRICAN  
CIVIL AVIATION AUTHORITY IMPOSING A FUEL LEVY ON THE SALE OF AVIATION FUEL**

The South African Civil Aviation Authority, in terms of the provisions of section 2 (7) of the South African Civil Aviation Authority Levies Act, 1998 (Act No. 41 of 1998), hereby amends the Determination published in Government Notice No. R1665 of 14 December 1998, as follows:


**Amendment of paragraph 2 of the Determination**

1. Paragraph 2 of the Determination is hereby amended by the substitution for subparagraph (1) of the following subparagraph:

“(1) Subject to the provisions of paragraph (2), a levy of twenty-two point eighty-six cents (R0.2286) per litre is payable by consumers (including a wholesale distributor) on the sale of all aviation fuel which is manufactured, distilled, imported or sold in the Republic for the year 2025/2026.”.

**Commencement date**

2. This Amendment will come into operation on 1 April 2025.
