The insulation lagging provided by the air-conditioning supplier has been found to be non-compliant and may cause large amounts of smoke in the cabin in the event of a fire.

2. Provide the number and description of occurrences that prompted the mandatory service bulletin:

No occurrences reported. Mandatory Service Bulletin action taken to improve the safety in case of engine fire, reducing the probability of propagating into the cabin.

3. How was the compliance time(s) established?

There have been no reported fire event and the fleet (100 aircraft) has accumulated approximately 383,000 hours based on 2017 figures from PAL Fleet Support. The insulation is located in areas which are separated from the cabin, and not supplied with a continuing air source.
