1. Describe the unsafe condition, AND its root cause. Include a description of how the problem could affect the safe operation of the aircraft:

It is possible that the Elevator Bellcrank Pivot joint could be assembled with a bolt that is a gauge size too short leaving threads inside the working section of the joint. This condition could create score / damage from the treads of the bolt on the internal bore of the Cross Tube hinge plate.

2. Provide the number and description of occurrences that prompted the mandatory service bulletin:

1 occurrence has been found in production and so the Mandatory Service Bulletin has been raised to confirm the safety of the fleet.

3. How was the compliance time(s) established?

Due to the importance of the joint in question in terms of flight safety it has been requested that the inspection is carried out at the next Check 1 (150 hr) inspection.

The fleet is 100 aircraft, and have accumulated approximately 383000 FH, there have been no reported cases of the elevator developing play in the field, therefore it has been determined that waiting until the next Check 1 inspection is an acceptable time frame.

4. Cost of parts and/or installation man hours?

<u>Material costs:</u> \$ 142.37 / <u>Man Hours:</u> 2 hours (inspection only) or 8 hours (for full accomplishment).
