

## Continued Airworthiness Notification to the International Community

**Subject:** This message is to advise you of the FAA's ongoing continued operational activities related to an accident on a Boeing Model 737-500 airplane.

**Situation description:** On January 9, 2021, Sriwijaya Air Flight SJ182, registration PK CLC, crashed shortly after takeoff over the 1000 island area of Indonesia (a group of islands just north of Jakarta on the island of Java). The plane was bound for West Kalimantan, Indonesia, on the island of Borneo. Fifty six passengers and six crew members were on board. A preliminary review of ADS-B data indicates that the airplane took off from Jakarta north bound over the Java Sea and at 11,000 feet descended rapidly into the water.

**Ongoing activities:** Komite Nasional Keselamatan Transportasi (KNKT), which is the Indonesian National Transportation Safety Committee (NTSC), will be leading the investigation into the accident, and under ICAO Annex 13 guidelines, they will notify and can request assistance from the United States Accredited Representative, the National Transportation Safety Board (NTSB). The FAA will serve as technical adviser to the Accredited Representative. We are in contact with the NTSB, and we stand ready to support the investigation as requested.
