

SCHEDULE**CONVENTION ON THE INTERNATIONAL RECOGNITION OF RIGHTS IN
AIRCRAFT ACT, 1993 (ACT No. 59 OF 1993)****SIXTH AMENDMENT OF THE MORTGAGING OF AIRCRAFT REGULATIONS, 2026****GENERAL EXPLANATORY NOTE:**

Interpretation

1. In this Schedule, "the Regulations" means the Mortgaging of Aircraft Regulations, 1997, published by Government Notice No. R. 1739 dated 24 December 1997, as amended.

Substitution of Regulation 8 of the Regulations

2. Regulation 8 is hereby amended, as follows:

“8 Fees

The following fees shall be payable when application is made for:

(a) The recording of a mortgage in the register of aircraft mortgages	[2255.00] <u>2359.00</u>
(b) A notification of the discharge of a mortgage	[2255.00] <u>2359.00</u>
(c) A transfer of mortgages by deed of cession	[2255.00] <u>2359.00</u>
(d) A declaration of transmission of rights in a mortgage	[2255.00] <u>2359.00</u>
(e) A certificate of mortgage	[1680.00] <u>1757.00</u>

Short Title and Commencement

3. This Amendment is called the Sixth Amendment of the Mortgaging of Aircraft Regulations, 2026 and shall come into operation 30 days after the date of promulgation in the Government Gazette.

(c) Die oordrag van verbande by middel van 'n sessieakte	[2255.00] <u>2359.00</u>
(d) Die verklaring van oordrag van regte in 'n verband	[2255.00] <u>2359.00</u>
(e) 'n Sertifikaat van verband	[1680.00] <u>1757.00</u>
