The aerodrome is located:

- 22.3km (12 NM) outside the FACT CTR boundary
- 5.6km (3 NM) from TMA FACT A boundary
- Beneath TMA FACT B (4500ft - FL85)
- Within FA-D200B training area
- Circuit altitude: 1,200ft ASL; Joining altitude: 2,000ft ASL

NB* All operations should remain clear of FACT Controlled Airspace, unless authorized.

In the event of any changes above that might affect FACT Controlled Airspace, there will be a requirement for us to review your request.

As stated above there is no requirement for a Letter of Procedure between ATNS FACT and Atlantic Aerodrome.
