The engine was started, and the aircraft was taxied to the runway threshold and aligned for take- off. The pilot reported that during climb, the aircraft experienced a downdraft and a further loss of lift. The pilot opted to execute a forced landing in a bushy type terrain as he had no other option.
TBA	03-01- 2022	ZS-NRJ	DeBeer Venetia Mine Airfield	Jetstream J41	Operation of Larger aircraft	LIMPOPO	0	On 3 January 2022 at approximately 0510Z, a Jetstream J41 twin-engine aircraft operated by Airlink with registration mark ZS-NRJ struck a bird with one of its right-side engine propeller blades during the landing roll at De-Beer Venetia Mine Runway in Musina, Limpopo Province. Onboard the aircraft were three crew members (the Captain, who was the pilot-in-command, First Officer [FO] and a cabin member) accompanied by four passengers on a scheduled commercial flight under the provisions of Part 121 of the Civil Aviation Regulations (CAR) 2011 as amended. The flight was conducted under Instruments Meteorological Conditions (IMC). According to the crew, during the landing roll when the FO was confirming if the spoilers were deployed, he saw a huge bird (Kori Bustard) approaching from the right-side of the aircraft on the runway in use. The bird flew into the right propeller and was struck by one of the blades. There was a severe vibration on No-2 engine. The Captain instantly shut down the affected engine and continued taxiing the aircraft towards the turning circle of Runway 26. After the No-2 engine had stopped, the crew noticed damage on one of the blades. The normal engine shutdown procedure was followed, and the aircraft was brought to a halt on the parking bay.

According to the design characteristics of the drone, upon loss of signa, it will divert from the point directly to the direction of a launched position. During a return flight the drone collided with the cooling exhaust tower at Hendrina Power Station which was between the pint of launch and the point where it lost the signal at the time

Towards the end of the field/spray run and during a climb and a left turn, the pilot felt a slight thud on the left wing. The pilot stated that after he had completed his turn and had lined up for his next run, he became aware of people running towards the end of the field. That is when he realised something was wrong. He then contacted the farmer who informed him that his son, who was taking a video of the aircraft as it was approaching during the spray run on the ground, was accidentally hit by the aircraft. The pilot navigated the aircraft towards the farm airstrip and landed safely. The son sustained serious injuries to his left knee and was rushed to hospital where he underwent surgery. From the video footage (taken by the son before the accident), two people (out of breath) are heard running (presumably towards the aircraft line of spray). According to the pilot, he was not aware of their presence in that area, and he did not see them.

This was followed by a loud thud sound. The instructor immediately took over the controls and checked for control integrity. No loss of control was experienced. They then routed back to FAPE and landed without incident. Upon landing, the inspected the aircraft and noticed that bird had struck the vertical stabilizer of the aircraft.

Upon taking off the pilot spotted eight suspects carrying the cable. He notified the security guards. The drone continued to follow the suspects and provide location overhead the suspects. The drone was approximately 500m from the pilot and the connection was good without any errors. After 13min of flight an error stating ESC malfunctioned, that resulted in the drone to spiral down and crashed whereafter disconnected from the pilot controller. When the drone crashed it was flying above about few meters from the suspects. Upon searching for the drone, the pilot only recovered pieces of the rotor and a tracking unit however the drone was not found at the crash site.

The circuit was flown in auto mode, as the circuit was finished there was adequate battery life remaining. The pilot proceeded in fly-by-wire (FWB) mode to area close to landing site to check if the vehicle spotted earlier was still parked at the same place. Shortly thereafter an orange caution message (Inertia Measurement Unit (IMU) attitude) popped up on the screen. Shortly thereafter the image on the screen spun around until there was no image displaying. The UAV disconnected and crashed. The pilot contacted dispatch to locate the Bidtrack and UAV was located moments thereafter.

The aircraft exited the runway to the right. The aircraft went over an embankment and nosed over coming to rest in an inverted position.

During the sixth spray the aircraft collided with the high-tension wires. The vertical stabilizer caught the wire and the pilot lost rudder effectivity. As a result, the pilot lost control of the aircraft and crashed about 800m from the wires. He further stated that he misjudged the wires as he normally flew under the wires during the previous spray runs. They were no fault with the aircraft prior to collision with the wires.

The pilot later un-paused to resume flight with new waypoints but had lost visual contact. He attempted to retrieve the aircraft by applying the return to home function (RTH), to no avail. The drone was not recovered.

He descended the RPAS closer to the object, but the drone started spiralling down and disconnected from the controller. The UAV crashed down to the ground. The pilot proceeded to the crash site to recover the damaged UAV. All parts were retrieved

The aircraft sustained damage to the left wing during the landing roll.

The water that was used for fire-fighting (bombing) was collected from Silver Mine Dam which is located in the vicinity of the nature reserve. The pilot further stated that during the dunking of the Bambi bucket, it appeared as if it did not fully submerge into the water. This resulted in the cable getting entangled during lifting of the Bambi. The pilot then elected to

								dump/release the load and repositioned the helicopter for landing to fix the entangled cable. While flying over a ridge, the pilot observed the bucket spinning (it disappeared from the mirror and from his line of vision). The wind was gusting whilst flying over the ridge, according to the pilot. He further stated that he descended the aircraft while keeping airspeed at 20 knots and landed safely on the soccer field at Chrysalis Academy. During walk-around, the pilot noticed the Bambi bucket in the vicinity of the tail rotor guard and some marks on the tail rotor blades and some abrasion marks on the tail rotor guard, indicative of the Bambi bucket coming into contact with the helicopter during flight/landing. The pilot did not experience any vibration nor loss of tail rotor authority during repositioning. He stated that the helicopter behaved normally. The aircraft damage was limited to tail rotor blades and no injuries were reported

During the take-off run on Runway 36 whilst at full power, the canopy opened. The pilot tried to grab the canopy, but was unable to as it opened very quickly. He applied the brakes and selected the throttled back to abort take-off, but the aircraft nosed over a result of his inputs; the propeller came to contact with the ground. The damages were limited to the propeller tips. No injuries were reported. During a follow-up with the AME who maintains the aircraft, he stated that he tested the latch, and the operation of the latch appeared to be serviceable. During a follow-up with the pilot, he stated that he had been flying the aircraft for the past 12 years and this was the first incident. He further stated that it was likely that the latch was not secured properly, resulting in the canopy opening during take-off.
