| 4. | In the case of a national flight instructor (gyroplane) the holder shall – <ul style="list-style-type: none"> • Have given not less than 30 hours of flight instruction within the three years preceding the date of expiry, of which not less than 25 hours shall have been given within the 12 months immediately preceding the date of expiry of such rating; and • Show proof of having attended a flight instructor refresher seminar as prescribed in document SA-CATS 62 within the two years immediately preceding the date of expiry of such rating; and • Have within 90 days immediately preceding the date of expiry of the rating have undergone the skills referred to in regulation 62.09.5. | | |
